### MINUTES EXECUTIVE COMMITTEE MEETING DECEMBER 5, 2019

President Cory Kief called to order the Association of Levee Boards of Louisiana's (ALBL) Executive Committee Meeting at 8:30 a.m., Thursday, December 5, 2019, at the Hilton New Orleans Riverside Hotel in New Orleans. There were sixteen (16) member agencies present which constituted a quorum.

Motion by Mr. Keahey, seconded by Mr. Minsky to approve the minutes of the August 16, 2019, Executive Committee Meeting. Motion passed without opposition.

The Financial Report was given by Ms. Monica Gorman who updated the budget from the last Executive Committee Meeting. The following balances formed the working capital of the ALBL: checking account \$121,550.45; savings \$70,786.74; Litigation Savings \$15,901.06, and Flood Insurance Coalition \$44,283.92. Motion by Mr. Callais, seconded by Mr. Rietschier, to accept the financial statement. Motion passed without opposition.

Mr. Reggie Dupre gave the Comprehensive Hurricane Protection Committee report and stated that Mr. Curole would like to develop a white paper for the upcoming 15<sup>th</sup> anniversary of Hurricane Katrina. He would like it to include an update on what has been done since the Hurricane and what still needs to be done.

Mr. Dupre also advised that a Memorandum of Understanding was signed on Wednesday, December 4, 2019, with Terrebonne Levee District, CPRA and USACE for the Morganza to the Gulf Project.

Mr. Kirkpatrick gave the Legislative Committee Report and stated that there was a handout in everyone's packet giving a summary of the Governor's election, a list of all newly elected legislators and a timeline of the upcoming legislative session. He stated that the new legislators will need education on Levee Districts and the issues that need to be focused on. Mr. Kirkpatrick will work on an educational handout that can be sent to all members of the legislature.

There was some discussion about the Association hosting a Wednesday event or the possibility of moving the May Workshop to Wednesday and Thursday to invite the legislators that are in session. Ms. White will contact the hosting hotel about the possibility.

Mr. Kirkpatrick also spoke about the watershed initiative and the importance of Association participation. The information provided in the presentation given by Ms. Alex Carter at this Annual Meeting was discussed. There are many different issues, possible complications, and many unknowns. Mr. Kirkpatrick suggested setting up a meeting with Mr. Pat Forbes and his personnel to get a better understanding of the process and future.

He also gave an update on the GOMESA Coalition which is pushing to get a greater share to benefit those along the coast. The bill passed out of the Senate Committee in November 2019.

Mr. Dupre advised that Terrebonne Levee District plans to push legislation that would include levee districts in the Title 32 exception for axles which is already in place for trucks hauling asphalt for DOTD.

Mr. Dwayne Bourgeois gave the Louisiana Flood Risk Coalition report and stated that the current expiration date of December 20, 2019, will likely be extended again. FEMA is set to introduce Risk Rate 2.0, which will have new mapping and a different rating approach, in October of 2021. Mr. Kief suggesting having FEMA come and speak at the May meeting to answer questions.

Motion by Mr. Bourgeois, seconded by Mr. Minsky to transfer \$22,500 from the Louisiana Flood Risk Coalition account to the checking account and to have a check sent to the Coalition to cover half of the current expenditures. Motion passed without opposition.

Mr. Minsky gave the Nominations Committee Report and stated that the 2020 nominations for ALBL and MVFCA are:

Mr. Kief added that he would like the Annual Meeting luncheon to be named the Edmond J. Preau, Jr. memorial luncheon. Motion passed without opposition.
